**No. PDS. 89/2013/163.-** In exercise of the powers conferred by the provision to Article 309 of the Constituition of India, the Governor of Assam is pleased to make the following rules to amend the Assam Economic and Statistical Service Rules, 1973 here-in-after referred to as the principal Rules, namely :-

Short title and commencement	1.	(1)	These rules maybe called the Assam Economic and Statistical Service (Amendment) Rules, 2022.
		(2)	They shall come into force on the date of their publication in the Official Gazette.
Amendment of rule 5	2.	In the principal Rules, in rule 5, clause (a) of sub-rules (5) and (6) shall be renumbered as sub-rule (5) and (6) respectively.	
Amendment of rule 7	3.	In the principal Rules, in rule 7,-	
		(i)	in sub-rule (3), the existing provisions in clauses (a),(b),(c) and (d) shall be deleted and subrule (3) shall be substituted by the following, namely :-
			"(3) The Appointing Authority shall consider the list so prepared by the Committee and approve the list unless it considers any change necessary. If the appointing authority considers it necessary to make any change in the list received from the Committee, then, it shall inform the Committee of the changes proposed and after taking into consideration, the comments, if any, as may in its opinion be just and

proper:

Provided that the selection list as approved by the selection committee shall form the select list for the purpose of appointment under sub-rules (2), (3), (4), (5), (6) and clause (a) of sub-rule (7) of rule 5 as the case may be."

(ii) sub-rule (4) shall be substituted by the following:-

"(4) The selection list prepared by the Committee shall be valid for one year from the date on which the list was finally approved by the Appointing Authority:

Provided that in the event of any grave lapse in the conduct or performance of duties on the part of any member in the select list, the Governor may, if he thinks fit, remove such member from the select list."
