NO.PDP.11/2015/93 dated 4-7-2016: To take forward the Geographic Information System and Remote Sensing (GIS/RS) initiatives in the state in matters of strategic planning and other relevant areas, a Committee of Secretaries is constituted with the following members to examine the possibilities and modalities required to go ahead.

2. Commissioner & Secretary, Finance Department : Member
3. Commissioner & Secretary, Science & Technology Department : Member
4. Commissioner & Secretary, Information Technology Department : Member
5. Secretary, Planning & Development Department/
Secretary, Science & Technology Department : Member Secretary
6. Director, Assam Science, Technology & Environment Council (ASTEC): Special Invitee
7. Director, Assam Electronic Development Corporation (AMTRON) : Special Invitee
8. SIO, NIC Assam State Unit : Special Invitee

The mandate of the committee will be:

1. Framing of a state policy for sharing of spatial and non spatial data created /to be created by Government departments/agencies using public money.
2. Reviewing the works already done under NDSAP 2012 and recommendations of earlier committee.
3. Analysing the progress in the (2) above and determining gaps required to be filled up.
4. Creation of database as done in Andhra Pradesh or elsewhere and the methodology for doing so.
5. Linking the database /projects to National Portal i.e. Bhuvan
6. Making information easily available to general public through easy access channels like Mobile Apps etc.
7. Devising a dynamic platform where database is regularly updated within a particular timeframe.
8. Building a mechanism for Government-Citizen interface,
9. Any other related issue

The Committee may co-opt any other person as special invitee if the need arises. All the secretarial and logistics support to the Committee will be given by the Planning & Development Department, Assam Science, Technology & Environment Council (ASTEC) and Assam Electronic Development Council (AMTRON). This cancels Department's earlier notification No.PDP.32/2011/192 dated 14-03-2013 and comes into force with immediate effect.
