Sir,

With reference to the subject cited above, I am directed to say that the para 2.1 and Annexure-IV (A) & (B) of Revised MLAADS Guidelines, 2013 has been amended as follows:-

- 1. The minimum value of an individual scheme mentioned in the para 2.1 of the Revised MLAADS Guidelines was raised from Rs.0.25 lakh to Rs.1.00 lakh. However, schemes with a minimum value of Rs.0.50 lakhs could also be taken up within the entitled amount of Rs.1.00 crore. The number of such schemes shall be limited to 5 (five) nos. per MLA per year.
- Format for Utilization Certificate is revised and enclosed herewith for your ready reference.

You are, therefore, requested kindly to follow the above guidelines at the time of execution of MLAAD Schemes.

Please read the first para 4.9 of the Revised MLAAD Guidelines, 2013 as funds lie unutilized/unspent with the Deputy "Sometimes MLAADS Commissioner of a district for many years due to non submission of Utilization Certificates by the Implementing Agencies/Construction Committees of previous installments. This happens more so, when the MLA is changed after the General Election or Bye Election. If such funds lie unspent for more than 2(two) years, the Deputy Commissioner of the district may officially close all such schemes on the recommendation of the sitting MLA and will re-allot the available fund for new scheme(s) on the recommendation of the such sitting MLA, so that all pending MLAAD funds could be utilized" instead of "Sometimes funds of a large number of schemes are lying unutilized due to change of MLAs after General Election. If the Construction Committees/Executing Agencies fail to submit utilization certificates even after repeated reminders, then in such cases, the Planning and Development Department may give direction to the Deputy Commissioners to close all such schemes and re-allot the available fund for new schemes as per recommendation of the Local MLA so that all pending MLAAD fund could be utilized for the purpose of the local needs". All the other conditions mentioned in the MLAADS Guidelines will remain the same.
