#### Assam's Endeavors in Achieving the SDGs

The **Sustainable Development Goals (SDGs)** were universally adopted in January 2016 as a call to action to end poverty, protect the planet and ensure that all people enjoy peace and prosperity. The 17 Goals which are to be achieved by 2030, were designed based on the learnings from Millennium Development Goals, through a global consultative process, to include many more new areas of focus such as Climate Change, Sustainable Consumption, Peace and Justice, and Innovation among many other key areas. The SDGs are based on the principle of forging partnerships and setting clear guidelines to achieving these targets as per the needs of each region

The **Prime Minister of India, Shri Narendra Modi**, in his speech addressing the United Nations on 25th September 2015 at the UN Sustainable Development Summit stated, 'Today, much of India's development agenda is mirrored in the Sustainable Development Goals.' Government of Assam, mirroring this commitment, under the leadership of **Chief Minister Shri Sarbananda Sonowal** strived to take forward the SDGs in Assam. Under the guidelines structured in the vision document called, 'Assam 2030: Our Dream, Our Commitment', a strategy was created to start the process of inducting SDGs into the policy planning processes of the Government of Assam. It is one of the first states in India and globally to start bringing SDGs into the policy discourse of the state.

To take forward these goals in Assam the Centre for Sustainable Development Goals (CSDGs) was established by Government of Assam in the Assam Administrative Staff College, Khanapara, Guwahati. The CSDGs as an institution, is a think-tank which provides research and technical support to all departments in the Government of Assam, to take forward their SDG targets. The Transformation & Development Department (T&D) is the nodal department for coordinating all the activities within departments for achieving the SDGs. An SDG Cell has also been established in the T&D Dept. to provide support to take forward SDG related activities.

#### SDG Goal 4 in Action

The work towards strategizing for the SDGs started with the Government Order (GO) dated 28<sup>th</sup> December 2015 issued by the **Chief Secretary, Government of Assam**. This was followed by an orientation conducted on 5<sup>th</sup> January 2016 and at the end of which 8 working groups were constituted to prepare the Strategy Paper and Action Plan (SPAPs) against the 17 SDGs. A second GO issued on 4<sup>th</sup> March 2017, by the Chief Secretary, Government of Assam, reinstated governments initiative and plans for taking forward the SDG goals. In preparation for the finalisation of these SPAPs 8 conclaves (based on 8 groups) have been planned by the Centre for SDGs and T & D Department for covering all the 17 goals. Quality Education (Goal 4), which is one of 17 Global Goals that make up the 2030 Agenda for Sustainable Development will help to address the major challenges facing in education sector in the state. This goal ensures that all girls and boys complete free primary and secondary schooling by 2030. It also aims to provide equal access to affordable vocational training, and to eliminate gender and wealth disparities with the aim of achieving universal access to a quality higher education. The Education Department has prepared a draft Strategy Paper & Action Plan (SPAP) with a vision to "All Children in School and Learning with Quality within and outside School"




Figure 2: Focus Areas under Mission (School Education)

Under each priority / Mission, some strategies and High Impact Interventions were formulated to address the state specific issues & challenges (Figure 2). Each priority / Mission also clearly stated the baseline as well as the target / achievement for the year 2030, outcome of the interventions, output indicators to assess the impact of the interventions, responsible implementing agencies, source of finance and their link with other SDGs.

#### State vision of Higher Education to Achieve Goal 4: Higher Education

The Assam Vision 2030 envisions that the Government will "Ensure quality education relevant to social context to all children in school and outside schools." As far as Higher Education is concerned this may be translated as "ensuring quality higher education for all to enhance employability and life skills through affordable technical, vocational and tertiary education."

The above vision is transmitted through following mission statements:

MISSION 1: Ensuring that all children in all social groups continue their education after accomplishing the secondary stage

MISSION 2: Ensuring quality of education with equity and increased learning outcomes

MISSION 3: Ensuring enabling policy environment and system for quality education with equal emphasis on technical, vocational and tertiary education. Creating systems for lifelong learning, developing emerging fields of learning for employability and promoting ICT.

Technical Session IV- Vocational training for increase of employment and decent work: Eliminate gender disparities in education and ensure equal access to all levels of education and vocational training for the vulnerable, including persons with disabilities, indigenous peoples and children in vulnerable situations

#### TECHNICAL SESSION: CONVERGENCE AND PARTNERSHIP FOR PROMOTING SDG-4.

Convergence and partnership with other government departments is important at policy formulation and implementation level, considering cross cutting and multi sectoral issues. This session will highlight some of the critical issues in Assam, especially for areas which require special attention like TG areas, Hilly areas, Char areas etc. It will aim to create a pathway, through the SPAPs, for Inter-departmental convergence, reflecting in the policy planning for SDG - 4 related programme

- ✓ Discussion and explore possibilities of convergence of policy and programme of Government Departments to achieve SDG -4
- Conceptualizing new partnerships and possibilities of collaboration between Inter and Intra Government Departments for achieving SDG -4
- ✓ Discussion on future convergence plan in the line of SPAPs and recommendations of the conclave.

#### **VALEDICTORY SESSION:**

The final session will take the inputs from all the technical sessions to finalize the SPAPs which were discussed throughout the day. It will use the inputs and recommendations made by experts to come out with a road map, through the 7 - year strategy paper and 3- year Action plan to achieve SDG -4 in Assam.
